Direction Of Use : Equipments : Foot stir up pump, Knapsack sprayer and domestic hand sprayer. Apply thoroughly on all surface converging dark corners and hidden places where mosquitoes rest.

- Precautions :**
- ◆ Avoid contact with mouth, eyes and skin
 - ◆ Avoid inhalation the dust powder.
 - ◆ Wash thoroughly the contaminated clothes & parts of the body after spraying.
 - ◆ Wear full protective clothing while spraying.

Antidote : Specific antidote is known. Treat symptomatically. Antihistamines may be given for allergic manifestations.

Storage Conditions : The packages containing the insecticides should be stored in separate rooms & premises meant for storing the product shall be well built, dry, cool well-lit and ventilated and of sufficient dimensions to avoid contamination with vapor.

Packing : Standard packing and match to statutory requirement for product and as per customer requirement.
